**ANSWER THE FOLLOWING QUESTIONS**

Yes       No      Will the irrigation system be installed in the Public Right-of-Way (begins at curb line and is approximately 10-15 feet in)?

City       Well      Type of water that will be used to irrigate. (Utilizing drainage/storm pond water is not allowed).

Yes       No      A rain sensor device will be required to be installed on all irrigation systems. (will verify on final inspection)

**CHECK TYPE OF BACKFLOW PREVENTER**

**Atmospheric:** The bottom of the device must be 12 inches above all sprinklers. No valves are allowed beyond this type of device.

**Pressure type:** The bottom of the device must be 12 inches above all sprinklers. Zone/yard valves may be installed after this type of device.

**Reduced Pressure Zone:** Required when neither the Atmospheric or Pressure type can be used due to elevation restrictions of the yard or dwelling; must be tested annually and rebuilt every five years by a certified person.

**PROCEDURE**

The Minnesota State Plumbing Code requires that a backflow preventer be installed on each lawn irrigation system. This is to prevent lawn fertilizers, weed killers and other contaminants from being drawn back into the drinking water system. **A licensed plumber or the property owner who occupies the home must install the backflow preventer.**

**Minnesota State Statute 103G.298 requires lawn irrigation systems be installed with a rain sensor device.** This is to prevent irrigating during times that there is sufficient moisture.

This application must be signed by the owner or applicant.

I, the undersigned, have read and understand the above and hereby acknowledge that when installing any part of this permitted system into the easement or right-of-way (typically 10-15 feet in from the back of curb line), the City of Sartell is held harmless for any breakage or disrepair to the system, which might occur when work is performed in the easement, right-of-way, street or abutting property.
