AN ANNUAL RESOLUTION DESIGNATING POLLING PLACES

RESOLUTION NO. 2020-41

WHEREAS, Minnesota Statute section 204B.16, subd. 1 requires an annual designation of a polling place for each election precinct; and

WHEREAS, on January 27, 2020 the Sartell City Council adopted Resolution No. 2020-07, confirming precincts and describing precinct boundaries; and

WHEREAS, due to the COVID-19 global pandemic, the Minnesota Secretary of State's Office is advising that polling places no longer take place in schools or congregate care settings. Currently, the Country Manor Campus, located at 520 1st Street NE serves as polling place precinct 2; and

WHEREAS, each jurisdiction has until July 1, 2020 to amend their polling places due to the COVID-19 pandemic; and

WHEREAS, voters previously assigned to the Country Manor Campus polling location will now be voting at Solid Rock Family Church, 301 1st Avenue NE; and

WHEREAS, the alternate polling location has been evaluated and recommended based on the criteria established and statutory requirements; and

NOW THEREFORE BE IT RESOLVED, that the Sartell City Council hereby designates polling locations as follows:

Precinct 1 will be at Sartell Community Center, 850 19th Street S and is described as follows: That part of the City of Sartell, Stearns County, Minnesota, lying easterly of Pinecone Road and south of 2nd Street South; and

Precinct 2 will be at Solid Rock Family Church, 301 1st Avenue NE and is described as follows: That part of the City of Sartell located in Benton County (everything east of the Mississippi River); and

Precinct 3 will be at Sartell Community Center, 850 19th Street S and is described as follows: That part of the City of Sartell, Stearns County, Minnesota, lying easterly of Pinecone Road, north of 2nd Street South, and south of 5th Street North; and

Precinct 4 will be at First United Methodist Church, 1107 Pinecone Road S and is described as follows: That part of the City of Sartell, Stearns County, Minnesota, lying westerly of Pinecone Road, south of 2 ½ Street North, and that portion south of 3rd Street North that lies west of 19th Avenue North; and

Precinct 5 will be at Messiah Lutheran Church, 320 4th Avenue N and is described as follows: That part of the City of Sartell, Stearns County, Minnesota, lying easterly of Pinecone Road, north of 5th Street North, south of 12th Street North; and

Precinct 6 will be at Celebration Lutheran Church, 1500 Pinecone Road N and is described as follows: That part of the City of Sartell, Stearns County, Minnesota, lying easterly of Pinecone Road North and north of 12th Street North, and west of Pinecone Road, north of 17th Street North; and

Precinct 7 will be at Sartell City Hall, 125 Pinecone Road N and is described as follows: That part of the City of Sartell, Stearns County, Minnesota, lying westerly of Pinecone Road, north of 2 ½ Street North, south of 17th Street North, and that portion north of 3rd Street North that lies west of 19th Avenue North, south of 17th Street North; and
